WEDDING PHOTOGRAPHIC WORK-FOR-HIRE AGREEMENT

This agreement constitutes an order for wedding portraiture services, including the taking of wedding pictures as agreed to by both parties: Marie W. Stephens Photography (Photographer) and Contracting Party (Client). Unless otherwise specified, it is understood that any and all rights to proofs, final or sample prints, thereof shall remain the property of Photographer and may be used for advertising, display or any other purpose thought proper by Photographer.

It is understood that the contracting party is responsible for providing a safe and professional atmosphere for our Photographer(s) and other staff to work. If at anytime our Photographer feels it is an unsafe or unprofessional environment, the package will be considered complete and our Photographer(s) and staff may leave and the Client(s) shall not be entitled to any refund of the package price. It is also understood that our Photographer(s) will not work in environments outside the photographic equipments' designed working parameters.

It is understood and agreed that no other photographer will be allowed to photograph or take pictures at the wedding while Marie W. Stephens Photography, her photographers and/or staff is working.

Photos shall be delivered on compact disk and are Clients to keep. All other photographic materials, including but not limited to negatives, digital files and transparencies, will be the exclusive property of Photographer.

If Photographer cannot perform this Agreement in whole or part due to a fire or other casualty, acts of God or nature or terror or other, cause beyond the control of the parties or due to Photographer's illness or injury, then Photographer will return all fees to the Client(s) but shall have no further liability with respect to this Agreement. This limitation of liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without the fault on the part of Marie W. Stephens Photography. Client(s) agree that a partial or entire wedding cannot be replicated, reenacted or repeated for the purpose of a photographic re-shoot and limits Photographer's liability to the amount paid under this contract.

Upon signing of this agreement by all parties hereto, Marie W. Stephens will reserve the date and time agreed upon and will not make another reservation for the specific time frame. For this reason, all deposits are non-refundable even if the date changed or the wedding becomes canceled for any reason.

The service fee is \$_____. This fee includes _____ hours of photography. A deposit of 50% of the total package price plus 100% of any anticipated travel fees are due at the signing of this agreement. The remainder is due two weeks prior to the wedding date payable by cash, check, credit/debit card, money order or certified check. Additional fees will apply if the venue is changed. These fees shall be paid in full prior to photography date. Deposit is subject to forfeiture if venue is changed and Photographer is not able to perform the services due to scheduling or other conflicts.

Personal checks returned due to insufficient funds will be charged a \$40.00 fee, and remaining balances must

be paid by cash, credit/debit card, money order or certified check. Any charges incurred to collect payment due to Marie W. Stephens Photography will be the responsibility of the Client(s).

Fees are non-refundable in case of cancellation or date change by client. I/we, the undersigned Client(s) hereby warrant that I am/we are competent to contract in my/our own name(s). I/we confirm that I/we have read the herein agreement prior to its execution and I/we are fully familiar with the contents thereof. This agreement shall be binding upon us and our heirs, legal representatives and assigns. And I/we certify that I/we have received a complete copy of this agreement with all blank lines completed.
